

Terms and Conditions

These apply to every person booked onto a course. If booking on behalf of a third party you accept these terms on their behalf and so it is important that you make them aware.

A) BOOKING AND FEES

1 - All places can only be reserved by us receiving a completed booking form and full payment or £75 deposit. Forms should be returned to Sandy Paterson Mountaineering, HM Flat, Plewlands House, Gordonstoun, Elgin, Moray, IV30 5RF.

2 - The balance of the fee is payable 8 weeks prior to the commencement of the course. In the event that the balance is not paid we will have the discretion to treat the booking as cancelled by the client and re-sell the course place.

3 - The whole course fee is required to reserve a place for any booking made within 8 weeks of the start of the course.

4 - Please note we are unable to accept bookings from under 18 year olds unless directly supervised by a parent or guardian.

B) CANCELLATION BY CLIENT

1 - All cancellations must be in writing (e-mail is acceptable).

2 - Sandy Paterson Mountaineering once notified by letter/e-mail of the cancellation will endeavour to re-sell the course place(s).

3 - In the event that the course is resold prior to the commencement of the course, the client will receive a full refund less 20% of the course fee to cover administration costs.

4 - Refunds will only be made after the start date of the course has commenced.

5 - In the event that the course is not resold prior to the commencement of the course, the client will be charged the following cancellation fees:-

- 50% of the total paid where cancellation takes place up to 8 weeks prior to the commencement of the course
- 75% of the total course fee where cancellation takes place less than 8 weeks before the commencement of the course
- 90% of the total course fee where cancellation takes place within the final 2 weeks before the commencement of the course.

C) CANCELLATION BY Sandy Paterson Mountaineering

1 - Whilst every attempt is made to ensure that advertised courses actually run, Sandy Paterson Mountaineering will notify the client of cancellation as soon as practicable where it believes on reasonable grounds that cancellation is necessary due to dangerous and/or unsuitable conditions for the course activity.

2 - Sandy Paterson Mountaineering shall notify the client of cancellation not less than five days prior to the commencement of the course where numbers as a result of client(s) cancellation failed to reach a workable minimum for the commencement of the course.

3 - In the event of cancellation clients will be offered the choice of the following options:-

- Full refund of the course fee paid;
- Another course on different dates.

D) SAFETY & PARTICIPATION STATEMENT

Climbing and mountaineering are activities with a danger of personal injury or death. By booking a course in these activities you are aware of and accept these risks and will be responsible for your own actions and involvement. We will teach you how to manage these risks but we can never completely remove them. You confirm that you are familiar with the nature of the activities that you wish to undertake and acknowledge those risks that are inherent therein and that you may freely withdraw from any activity without penalty and there is no pressure whatsoever to take part.

E) INSURANCE & LOSS

Our courses do not include any personal accident, cancellation, third party liability or personal injury insurance. We recommend that you take out your own policy and have a list of recommended insurers on our website. We will accept no responsibility whatsoever in respect of loss or damage to personal property.
